Minutes McCormick Town Council Regular Meeting *Tuesday, May 9, 2023 - 7:00 PM* McCormick One Stop Conference Room 109 W. Augusta St., McCormick, SC Welcome & Comments

Mayor Smith welcomed all those in attendance to the regular meeting of the McCormick Town Council at approximately 7:00 p.m., stating that Council Members Nathan Jones and Alvin Jennings would not be present, as well as Fire Chief Mike Barron.

Notice of Meeting – In accordance with the Freedom of Information Act, Chapter 4, Title 30, Code of Laws of South Carolina, 1976, as amended, an agenda had been posted on the rear entrance door of the McCormick One Stop Building, 109 West Augusta Street, as well as posted in the Town's Kiosk, 117 West Augusta Street, giving public notice of the meeting, copies were emailed to news media, Journal-Messenger and the Index-Journal, those requesting notice of meetings, and posting was done on the Town's website.

FOIA Notification – those requesting agenda packages were given said packages at the meeting, April 11, 2023.

1.Call to Order -

Quorum Confirmation Pledge of Allegiance Invocation

Mayor Smith called for quorum confirmation; Clerk/Treasurer Mrs. McKinney stated that with four council members and the mayor, as a voting member, the same constituted a quorum.

Mayor Smith then called for the Pledge of Allegiance which was offered in a patriotic manner by all those present.

Invocation was given by Mayor Smtih – being thankful for a beautiful day, refreshing air and sun; seeking mercy and blessings for family and community; those present and those absent; and seeking guidance in tongue, thought, and mind in the conduct of the meeting.

*2. Approval of Agenda as Written –

Mayor Smith called for council action regarding the agenda as written. Council Member Dansby made a motion that the agenda be approved as written, said motion being duly seconded by Council Member Hood, and unanimously approved.

3. Appearance of Citizens -

A) Everette Hall – Youth Empowerment – McCormick County

Present and presenting information regarding Youth Empowerment – McCormick County – was Pastor Everette Hall. Pastor Hall spoke to Council regarding his passion to help the youth of the community in giving something back to the community. He handed out to Council information as to who and what Youth Empowerment is and does, citing the mission of the organization. He thanked Council for their past support of the organization's efforts.

Mayor Smtih thanked Pastor Hall for his attendance; he stated from the information there were three levels of support, and that the information given would be presented at the next meeting of Council with decision being made at that time regarding.

Council had received copies of the regular Town Council Business Items for review prior to the meeting; Mayor Smith called for any questions or comments regarding and none were offered. None were offered. He then closed the public hearing at approximately 7:15 pm.

Council had received copies of all of the Legislative items for review prior the meeting.

Mayor Smtih stated there were two ordinances for introduction and first reading and called for questions or comments regarding same. None were offered. He then called for council action for Ordinance 2023-06-13-01.

Council Member Dansby made a motion to approve first reading, said motion being duly seconded by Council Member Chiles, and unanimously approved.

Mayor Smith called for council action regarding Ordinance 2023-06-13-02, Comprehensive Plan Update.

Town Clerk/Treasurer Mrs. McKinney asked if she could speak and was permitted to do so. She stated that several of the Planning Commission members were present, as well as Rick Green, from Upper Savannah, who had facilitated the Planning Commission meetings to update the Town's Comprehensive Plan. She thanked them for their attendance at those meetings and their work to update the Plan.

Mayor Smith also thanked the Planning Commission members and Mr. Green, thanking them for their service to the community.

Mayor Smith then called for council action regarding Ordnance 2023-06-13-02, Comprehensive Plan Update.

Council Member Dansby made the motion, said motion being duly seconded by Council Member Chiles, and unanimously approved.

Mayor Smtih stated there were no Resolutions to consider, and stated there was one Proclamation – May -Mental Health Month.

Mayor Smith stated that Linda Kidd usually sent information as to any events for May and the Mental Health Proclamation and asked the Clerk/Treasurer to see that council was given any information later on regarding any events.

Council Member Chiles directing question to Police Chief Willis regarding police report, asked, due to shortage in the Police Department, were there any applicants.

Chief Willis stated there was one applicant who was certified. He also gave information regarding the police candidate who was at the Academy who had about two weeks left, and when finished, and with the applicant possibly being added, the Department would have four officers.

Council Member Dansby asked if there would bring the department current, and Chief Willis stated that he would still be without three - the department having a force of seven officers.

Calling for any other questions or comments and receiving none, Mayor Smith called for council action regarding the reports.

Council Member Chiles made the motion to approve the reports, said motion duly seconded by Council Members Franklin and Dansby, and unanimously approved.

8. New Business -

Council had received information regarding New Business items prior to the meeting for review.

Mayor Smith stated the MASC annual meeting would be held in July in Greenville and that the 2023 Premium Pay for Essential Workers would be processed sometime during the next weeks. No questions or comments were offered regarding the new business items.

Update on Streetscape Project – Veterans Park, Town Parking Lot Mayor Smith stated that SITEC had started, but had some setbacks, but would be back on track.

Trunks of Gold – May 6

Mayor Smith stated that this, too, seemed to have a good turnout, with some 60 vendors participating.

He stated he also attended the event for Shaaron Kohl, who had moved to Florida, having been a part of the McCormick Community for some time, she having done many good things, and owning the Red Rooster business downtown. He stated he presented her with a plaque and the key to the city.

He stated he would be attending the Valor Luncheon – May 11 – at the Dorn Mill.

Council Member Dansby made the motion to adjourn, said motion duly seconded by Council Member Hood, and unanimously approved.
